Appendix 2: Statistical testing of osteological dating methods

dating methods by Richard Wright

INTRODUCTION

One of the aims research aims of the project was to test the reliability of various osteological dating techniques on skeletons of known chronological age. The data is discussed in Chapter 7 above. The statistical tests undertaken as part of the work and their results are presented below.

AIM OF THE ANALYSIS

The aim of the analysis was to examine the correlation between known age at death derived from *departum* plates and six conventional age indicators. Table 7.3 gives the youngest and oldest implied age limits for each individual for each of the six age indicators. To simplify these data to a single number the average of the implied limits for each case was taken, but the averages between each of the six age indicators were not merged.

MULTIPLE LINEAR REGRESSION

The results for the six age indicators are available. Combining all six into a single Multiple Linear Regression equation (MLR) seems an obvious way to proceed (Draper and Smith 1998, chapter 9; Zar 1999, chapter 20). MLR simultaneously examines the correlation between known age at death (the independent variable) and all age indicators (the dependent variables).

Unfortunately MLR requires that each individual has a complete set of observations for each of the six ageing methods. The data is however, far from complete, and in fact only three of the 53 individuals has a complete set for the six age indicators. Yet by reducing the ageing methods to four it is possible to extract data for 13 of the 53 individuals of known age. MLR could be carried out on these 13 individuals and their four age indicators.

REGRESSION USING INDIVIDUAL AGE INDICATORS

In order not to sacrifice information latent in the incomplete sets of data for the remaining 40 individuals, the six age indicators were examined individually. None of these six analyses used all 53 individuals, but rather used different numbers and combinations of individuals (see Table 7.3).

All six individual analyses assume that the known age of death is the independent variable (i.e. the X axis) and the age implied by ageing indicators

is the dependent variable (i.e. the Y axis). The lines of best fit considered for use in these analyses are of two types (Zar 1999, chapter 21):

The graph of a 1st degree polynomial, which is a linear function, as with a linear regression line.

The graph is a 2nd degree polynomial, which is a parabola.

Polynomials beyond a degree of two will fit the data points better, yet with such a small amount of data there is the risk of overfitting. For example, higher degree polynomials risk creating a curve that suggests age degeneration reverses itself in certain age groups, i.e. the curve rises then falls again. Yet enamel on the tooth crowns cannot repair itself after attrition, nor, so far as is known, can pubic symphisis reverse degenerative age changes. Because repair has not been reported in the relevant osteological studies such mathematical 'best fits' must be excluded.

To choose the lines of best fit a statistical package LeoStatistic has been used. This package can be downloaded from: http://www.leokrut.com/leostatistic/

Leostatistic was used specifically to search for the 'best formula'. The best formula may not be polynomial. If it is not, and to keep analyses consistent, it is necessary to look for a polynomial fit that is close enough to the 'best formula' as to make no substantive difference in the display. No problems were found in finding a suitable polynomial.

RESULTS

Multiple Linear Regression

The result for the MLR of 13 individuals has a correlation R of 0.836. The regression is statistically significant, with a probability of 0.031. These results mean that for the 13 individuals there is a high degree of correlation between known age at death and the four ageing indicators examined simultaneously.

Do all the indicators contribute equally to the MLR result? To answer this we can look at the weights of the age indicators:

This table shows that Auricular Surface, with a standardized beta coefficient of 0.731, has by far the greatest weight. It is followed, with a major gap, by Pubic Symphysis (S & B) at 0.199. Yet of these two indicators only Auricular Surface has a probability that is statistically significant at the 0.05 level.

In summary, this multiple linear regression (of 13 of the 53 individuals) suggests that more complete data would provide useful predictions of age by using the four age indicators in question. Auricular Surface is likely to have the main weight in the equation of age indication.

To judge by the distributions of the individual indicators (shown below) any future work using MLR is likely to benefit from normalisation of some of the indicators to create more linear distributions.

Regression for the individual age indicators


The use of LeoStatistic led to graphs for 2nd degree polynomial fits for all six indicators. Note however that the lines for sternal rib ends and attrition are virtually linear.

DISCUSSION

The distributions of the six indicators show that Auricular Surface has the highest correlation with known age at death. This result agrees with the MLR of a smaller number of individuals. Overall the results suggest that the age related changes of Pubic Symphysis and Auricular Surface stop around the age of 55. So there may be no value in expanding reference samples to include older people. Yet there is no such asymptote shown in the analysis of Sternal Rib End. They continue to degenerate into old age, though variance increases markedly with age. Suture closure shows virtually no positive slope and virtually no correlation. This unpromising result will be of no surprise to osteologists. Dental attrition increases exponentially with age. The explanation for this deviation from linearity is perhaps related to increasing tooth loss with age, the loss inflicting greater attritional load on the surviving teeth. None of the analyses shows a systematic over estimation of the age of young adults.

Comparison with Spitalfields

Comparisons can be made with the ageing results reported for Spitalfields. Use of the so-called Complex Method at Spitalfields showed major and systematic over estimation of the age of young adults and under estimation of the age of older adults (Molleson & Cox 1993, p.171). For St George's, Bloomsbury, we do not see systematic over estimation of the age of young adults. The results for ageing younger individuals are therefore much more encouraging than those from Spitalfields. Yet under estimation of the age of older adults does occur at St George's, and is perhaps to be explained by the stopping of the relevant degenerative changes around the age of 55 years old. It is interesting to note that by far the most successful ageing method for St George's, both in MLR and as an individual age indicator, is Auricular Surface. This method is not one of those used at Spitalfields.





Fig. A2.2 Regression: ageing using pubic symphysis (Suchey & Brooks)




Fig. A2.4 Regression: ageing using sternal rib end





Fig. A2.5 Regression: ageing using cranial suture closure
