

#### LICENCE FOR THE REMOVAL OF HUMAN REMAINS

The Secretary of State, in exercise of the power vested in him by section 25 of the Burial Act 1857 (20 & 21 Vic., cap.81), grants a licence for the removal of the remains of **persons unknown** from the place in which they are now interred at **131 Slough Road**, **Datchet**, **Berkshire**, **SL3 9AE**.

- 2. It is a condition of this licence that the following precautions shall be observed:
  - (a) Any removal or disturbance shall be effected with due care and attention to decency;
  - (b) The ground in which the remains are interred shall be screened from the public gaze while the work of removal is in progress;
  - (c) The remains shall, no later than 31 December 2013, be reinterred at 131 Slough Road, Berkshire. In the meantime, shall be kept safely, privately and decently by Oxford Archaeology under the control of a competent member of staff.
- 3. This licence merely exempts those from the penalties, which would be incurred if the removal took place without a licence. It does not in any way alter civil rights. It does not confer the right to bury the remains in any place where such right does not already exist.
- This licence expires on 30 September 2013.
