Summary

On the 29th and 30st March 2012, Oxford Archaeology (OA) carried out an Archaeological Watching Brief at Hampton Court Palace during the installation of new signposts in and around The Wilderness. Nine foundation holes were excavated, seven within The Wilderness to the north of the main Palace complex, one on the Broad Walk to the north of the East Front, and one on the eastern side of the former Tiltyard. The work which was commissioned by Historic Royal Palaces (HRP) only revealed modern topsoil and subsoil deposits.

1 Introduction

1.1 Scope of work




Figure 1: Site location

- 1.1.1 Oxford Archaeology (OA) were commissioned by Sharon Kerrigan of Historic Royal Palaces to undertake an Archaeological Watching Brief during the installation of external signage at Hampton Court Palace, near Hampton, Surrey. The Site is centred on National Grid Reference TQ 515736 168702 (Fig. 1).
- 1.1.2 The works, which took place on the 29th and 30th March 2012, consisted of the excavation of eight foundation holes for 'fingerpost signs' and one foundation hole for a normal sign-post (henceforth all locations will be referred to, and labelled on the figures as, 'signposts'). Nine foundation holes were excavated, seven within The Wilderness to the north of the main Palace complex, one on the Broad Walk to the north of the East Front adjacent to the entrance to The Wilderness, and one on the eastern side of the former Tiltyard, to the south of the Tiltyard Cafe. The foundation holes measured between 0.3 and 0.5 m square and 0.7 m deep, and in two locations these replaced existing signs (Fig. 2).

1.2 Geology and topography

- 1.2.1 The Site is situated on the First Terrace Drift Geology in the flood plain of the River Thames, which overlies London Clay.
- 1.2.2 The Site is relatively level and lies at a height of *c* 9 m above OD.

1.3 Archaeological and historical background

1.3.1 Hampton Court Palace is a Scheduled Ancient Monument (Surrey No. 83) of outstanding national importance. The wider historical background to the Palace has been well documented and is not necessary to repeat here.

2 Project Aims and Methodology

2.1 Aims

- 2.1.1 To identify and record the presence/absence, extent, condition, quality and date of archaeological remains in the areas affected by the groundworks.
- 2.1.2 To make available the results of the archaeological investigation.

2.2 Methodology

2.2.1 All of the foundation holes were hand excavated with the attending archaeologist present. Signposts 2 and 7 (Fig 2) involved the removal of an existing sign followed by



- deepening the existing foundation hole. The other foundation holes were hand excavated through lawned areas, flanked by pathways.
- 2.2.2 All of the foundation holes were located on a plan at a scale of 1:1250. All excavated features were photographed using a digital camera. A general photographic record of the work was made. Recording followed procedures detailed in the *OAU Fieldwork Manual* (ed. D Wilkinson, 1992).

3 RESULTS

3.1 Description of deposits

- 3.1.1 Signpost foundation holes 1 and 2 only showed evidence of the existing, silty topsoil.
- 3.1.2 Signpost foundation holes 3, 5, 6, 7, 8 and 9 all contained the current topsoil to a depth of between 0.3 and 0.5m. This overlay a clayey, silty sandy buried soil or subsoil which continued beyond the bottom of the excavations.
- 3.1.3 Signpost 4 consisted of 0.4m of modern, silty topsoil overlying the foundations to a twentieth century garden wall which the sign abutted to the east.

3.2.1 No finds were recovered

4 Discussion and conclusions

4.1.1 Although the watching brief provided limited access or visibility of the deposits within The Wilderness, there was consistency within the deposits seen, with c. 0.4 m of



- current topsoil overlying 0.3 m of buried soil or subsoil suggests there has been little disturbance throughout the area.
- 4.1.2 The origins of the buried soil or subsoil are difficult to ascertain due to the conditions in which it was seen. It is possible that it is either an undisturbed subsoil overlying the natural gravel deposits, or it is a consistent levelling deposit spread throughout the area, possibly dating from a period of significant redevelopment of the Palace, both have been excavated within the Palace Gardens previously.
